



PRIVACY POLICY

This privacy policy for ADIO ("we," "us," or "our"), describes how and why we collect, store, use, and/or share ("process") your information when you use our services ("Services"), such as when you:

Visit our website at <https://adio.one> and activate the ADIO Receiver

Personal Information:

*In Short: We **DO NOT** process personal information and do not ask you to provide it.*

What personal information do we process?

We **DO NOT** process any personal information when you visit, use, or activate ADIO.

In what situations do we share personal information?

We **DO NOT** process but would **NEVER** share any personal information inadvertently obtained you visit, use, or activate ADIO.

How do we keep your personal information safe?

While we **DO NOT** process your personal information, we do have organizational and technical processes and procedures in place to protect information.

What Information do we process?

***In Short:** Some information — such as your Internet Protocol (IP) address and/or browser and device characteristics — is processed automatically by our web servers when you visit, use, or activate ADIO.*

What Information do we process?

Our Web Servers automatically process certain information when you visit, use, or navigate the Services. This information **does not reveal your specific identity** (*like your name or contact information*) but may include device and usage information, such as your IP address, browser and device characteristics, operating system, language preferences, referring URL, ISP location, information about how and when you use our Services, and other error information. This information is needed to maintain the security and operation of our Services, and for our internal analytics, reporting, and efficiency purposes.

In what situations do we share information?

We **NEVER** share any information automatically processed by our Web Servers when you visit, use, or activate ADIO.

How do we keep information safe?

We have implemented appropriate and reasonable technical and organizational security measures designed to protect the security of all information we process.

HOWEVER, DESPITE OUR SAFEGUARDS AND EFFORTS TO SECURE INFORMATION, NO ELECTRONIC TRANSMISSION OVER THE INTERNET OR INFORMATION STORAGE TECHNOLOGY CAN BE GUARANTEED TO BE 100% SECURE, SO WE CANNOT PROMISE OR GUARANTEE THAT HACKERS, CYBERCRIMINALS, OR OTHER UNAUTHORIZED THIRD PARTIES WILL NOT BE ABLE TO DEFEAT OUR SECURITY AND IMPROPERLY COLLECT, ACCESS, STEAL, OR MODIFY AUTOMATICALLY PROCESSED INFORMATION. ALTHOUGH WE DO OUR BEST TO PROTECT AUTOMATICALLY PROCESSED INFORMATION, YOU SHOULD ONLY ACCESS OUR SERVICES FROM A SECURE BROWSER AND DO SO AT YOUR OWN RISK.

We may need to update this privacy policy from time to time, but we will always be guided by our principal of **protecting the rights of the individual.**
